Data Privacy Notice in conjunction with the Membership Form and the Direct Debit Mandate:

Friends of BIS (FoBIS) falls under the requirements on unified processing of personal data of the General Data Protection Regulation (GDPR) of the European Union. FoBIS installed organisational and technical measurements to create a high security level for the protection of your data, strictly following the GDPR as well as German Data Protection Act and other relevant data protection provisions. To register you as a member and complete the direct debit mandate, your aforementioned personal data are collected and processed. The usage by or transfer to uninvolved third parties is excluded.

2. Data Protection Officer Contact Details

Per law, FoBIS does not require an appointed Data Protection Officer (DPO). You may contact the DPO of the Bavarian International School gAG at dataprotection@bis-school.com.

3. Purpose and Legal Basis of Processing

Your personal data will be processed to register you in the membership database of FoBIS in conjunction with the statutes and membership registration.

Your banking data will be processed for the purpose of transacting the direct debit for accounts receivable of Friends of BIS e.V. Legal basis of processing is the direct debit mandate issued by you in conjunction with the membership registration (Art. 6 Sec. 1 lit. b) GDPR).

4. Categories and Processing of Personal Data

The personal data processed for the purpose aforementioned, result from the membership form and direct debit mandate template. Once the signed form is received, BIS will save the data provided by you to proceed with the registration in the membership database and the direct debit of accounts receivable. With the direct debit process, the data will be submitted via data transfer to the banking institution stated in the form.

Your personal data will be saved until you end your membership or withdraw your mandate. Please note that the withdrawal only has future effects. Moreover, your data may not be deleted during the timeframe we have to comply with legal retention or limitation periods.

5. Your Data Protection Rights

You may have certain rights under the data protection law. These include the right to ask FoBIS for a copy of your personal data, to correct, delete or restrict processing of it. You may have the right to object to processing. (Art. 15 – 18, Sec. 2 sentence 1 GDPR).

These rights may be limited in some situations – for example, where we can demonstrate that we have a legal requirement to process your data. (z.B. German Fiscal Code, German Data Protection Act).

If you have unresolved concerns, you have the right to complain to a data protection authority (Art. 77 GDPR).
